**1. ENTRY FEE AND PROCEDURE**

- 1.1 The registrations for the 24 HOURS KARTING OF ITALY will open on Monday November 27<sup>th</sup> and will close when the maximum number of 42 karts admitted will be reached.

**2. TECHNICAL SERVICES**

- 2.1 The services included in the entry fee are the following:
- a) Rental of 1 Kart CRG Centurion equipped with 4 stroke engine and on-board telemetry;
  - b) Technical assistance provided by a central structure, including spare parts (even from accidents) and consumption materials;
  - c) Pit and track services (race direction, stewards, medical assistance, etc.)
